Response:


The Govt. college of Pharmacy, Rohru offers three Add-on/ certificate courses to the willing students. These courses include NCC, NSS, and Hospital training.

The duration, enrolment, and attendance of these courses are regulated as per the guidelines of a specific agency, i.e. NCC, NSS, and concerned hospital (for hospital training). The issue of the certificate to these courses is strictly based on the complete attendance of the students and therefore attainment of a certificate could be considered as the indicator of complete attendance.

Therefore following is submitted for consideration:

1. NCC course is of 3-year duration during which many activities are performed, which are mandatory for the successful completion of the course. The attendance of the NCC cadets during various camps/training/ drills/ events etc. is maintained by the NCC Hq under which the activity is being conducted. For example, the previous year the Annual Training Camp of the NCC Cadets was conducted by the 8HP Bn NCC, Rampur at Lal Bahadur Shastri Government College Saraswati Nagar, Rohru Himachal Pradesh. In this camp, a total of 16 cadets participated and their attendance was recorded there only based on which the cadets were issued certificates.
2. The attendance of the NSS activities is recorded in the NSS work diary. The same is being provided for your reference.
3. Hospital training is conducted and completed under the guidelines of the PCI. During this course, students have to attend a hospital training program at any hospital for 30 days. Only those students who fulfill the criteria of completing 30-days of training are provided with a certificate. In this case, also attendance is marked by the concerned hospital.
4. Therefore the award of certificates could be considered as the indicator of complete attendance and the same is being requested to be considered.

1. National Cadet Corps (NCC)

Name of the Programme: National Cadet Corps (NCC)

Duration of the program: 3 years depends on the Tenure for the certificate exams.


To get a certificate NCC Volunteers should full fill the following criteria:

“A” Certificate

The Cadet must have participated in a minimum of 75% of all training sessions specified in the Junior Division/Wing NCC programme for the first and second years (All Wings). The interruption in the cadet's NCC Training Tenure prior to his participating in the exam must not be longer than 12 months in order for his prior tenure to be counted. If the break is longer than 12 months, the procedure listed below will be followed: If he was on the unit rolls for at least two years prior to discharge and had attended 75% of the total training sessions during his NCC tenure, he will need an additional 36 training sessions before he is qualified to sit for the Certificate A examination. In all other circumstances, when the aforementioned requirements are not met, the cadet must attend a minimum of 75% of the first and second years' training sessions a minimum of one Annual training camp.


“B” Certificate

For Senior Division/Wing NCC, the cadet must have completed at least 75% of the total training hours outlined in the syllabus for the first and second years (All Wings). For the Certificate B Examination, the cadet SD or SW's tenure in the NCC Training should not have been interrupted for more than 18 months at a time following discharge. The next step will be taken if the break is more than 18 months. He would require an additional 36 periods of training in order to be qualified to stand for the B Certificate if he had been on the unit rolls for at least two years prior. In all other circumstances, when the aforementioned requirements are not met, the cadet must attend a minimum of 75% of the first and second training years' sessions. One Annual Training Camp, NIC, COC, RDC, or Attachment with Regular Army, Navy, or Air Force must have been attended. Cadets who have a Certificate A will receive 10 bonus points. Or to discharge and had attended 75% of the total training sessions during his NCC tenure.

“C” Certificate

The cadet needs to have a Certificate B. The third year of Senior Division/Senior Wing NCC Training is required for the cadet. A minimum of 75% of the third-year syllabus's scheduled classes must have been attended by the cadet during the academic year. Before taking the exam, the cadet SD or SW's break in NCC training tenure shall not last longer than 18 months at a time after his release in order to count his prior tenure for the Certificate C examination. If the break is longer than 18 months, the following procedure will be followed: If the individual had been on the unit rolls for at least two years prior to discharge and had attended 75% of the total time during his NCC tenure, he will require an additional 30 training sessions in order to be qualified to take the Certificate C examination. The cadet must attend a minimum of 75% of the training sessions during the third year in any other circumstances when the aforementioned requirements are not met. In a three-year period, the employee must have attended one ATC and one additional training event at Delhi, the Republic Day Camp (RDC). Camp that is centralized run (COC). HQ DGNCC Para Training Camp issued the order (PTC). Camp Training Paradox (PTC). (When appropriate for SD/SW Cadets) National Integration Camp (NIC). Expedition for All India Trekking (HQ DGNCC Organized). Expedition to Mount Everest in All of India (HQ DGNCC Organized). Only after passing the Certificate B exam will cadets be permitted to sit for the Certificate C exam.

NSS activities have been classified into two major groups:-

A) Regular NSS Activities:

Students undertake various activities in the Adopted villages, college campus, and urban slums during weekends or after college hours.

The volunteers undertake various activities in adopted villages and urban slums for community service. They should put in 120 hours of service such as:


- i. Orientation of NSS volunteers - 20 hours. (Lectures, discussions, field visits, audio-visuals)
- ii. Campus work/ project involved in the projects for the benefit of institution and college students – 30 hours
- iii. Community service in adopted villages/ urban slums -70 ours

B) Special Camping Programme:

Camps of 7 days duration are organized in adopted villages/urban slums during vacations with some specific project by involving the local community. 50% enrolment of NSS volunteers is expected to participate in these camps.

Program could be evaluated by the organization based on Regular activity and Special Camp activities.

At the end of the program students will be able to learn about their strengths and weaknesses and learn amazing skills, and qualities like leadership and teamwork among people with different streams. In this program, students will explore different cultures, mentalities and actual situations/problems in different parts of the state, in villages, in different parts of the country, and even different nations through NSS special camps, state camps, National camps, and International Exchange programs. Students learn a lot about participating, performing, and organizing an event. It helps in developing public speaking quality. It makes you a socially active and responsible person. You will learn to stand up differently among the crowd. The program develops problem-solving skills, and will be able to solve real-life and practical problems.
