### **NOTIFICATION**

Having regard to the Government of India Notification No. 1-32/2006-U-II U.1 (i) dated 31<sup>st</sup> December, 2008 and 23-1/2008-TS.II dated 7<sup>th</sup> October, 2009 and subsequent Notification No. F. No. 37-3/Legal/2010, dated 5<sup>th</sup> March, 2010 of the All India Council For Technical Education and the Notification No. 2/259/09-4TE2/2581 dated 18<sup>th</sup> June, 2010 of the Government of Punjab and after making suitable modification, the Governor Himachal Pradesh is pleased to revise the pay scales and other service conditions of the teaching staff of the Government degree level technical institutions as under:-

- 1.1 This Notification shall apply to all the degree level technical institutions established by the State Government such as Government Pharmacy College Rohroo, Distt. Shimla, Jawahar Lal Nchru Government Engineering College Sundernagar, Distt. Mandi, Atal Bihari Vajpayee Government Institute of Engineering & Technology Pragatinagar, Distt. Shimla and any other technical institution which may be set up by it.
- 1.2 This Notification shall apply to all the degree level technical institutions imparting technical education as may be notified by the State Government from time to time.
- 1.3 This Notification shall apply to the regular Teachers and Librarians working in the degree level technical institutions, and not to the contract employees.
- 1.4 This Notification shall not apply to the posts of professionals like System Analysts, Senior Analysts, Research Officers etc. and the ministerial and other non-teaching technical staff working in the technical institutions.
- 1.5 This Notification shall not apply to the teaching faculty and other staff of the Government Polytechnics.
- 1.6 This Notification shall come in to force with effect from the date of notification.

### General

- There shall be only three designations in respect of teachers in these technical institutions namely, Assistant Professors, Associate Professors and Professors.
- (ii) All Principals working in these technical institutions shall be redesignated as Directors / Principals from the date of issue of this notification.
- (iii) However, there shall be no change in the present designations in respect of the Library personnel working at various levels in these technical institutions.

# <u>Pay Scales, Service conditions and Career Advancement Scheme for</u> teachers and equivalent positions:

The pay structure for different categories of teachers and equivalent positions shall be as under:-

## (a) Assistant Professors/Associate Professors/Professors In Technical Institutions

- (i) Persons entering the teaching profession in technical institutions shall be designated as Assistant Professors and shall be placed in the Pay Band of ₹15600-39100 with AGP of ₹6000 Lecturers already in service in the pre-revised scale of ₹8000-13500, shall be re-designated as Assistant professors with the said AGP of ₹6000....
- (ii) An Assistant Professor with completed service of 4 years, possessing Ph. D. Degree in the relevant branch / discipline shall be eligible, for moving up to AGP of ₹7000.
- (iii) Assistant Professors possessing Master's degree in the relevant branch / discipline as defined for technical education shall be eligible for the AGP of ₹7,000 after completion of 5 years service as Assistant Professors.
- (iv) Assistant Professors who do not have Ph. D. or a Master's degree in the relevant branch / discipline of a programme shall be eligible for the AGP of ₹7,000 only after completion of 6 years' service as Assistant Professors.
- (v) The upward movement from AGP of ₹6000 to AGP of ₹7000 for all Assistant Professors shall be subject to their satisfying other conditions as laid down by AICTE and the State Covernment.

- (vi) The incumbents of the posts of Lecturers (senior scale) (i.e. the prerevised scale of ₹10,000-15200) shall be re-designated as Assistant Professors, and shall be fixed at the appropriate stage in Pay Band of ₹15600-39100 based on their present pay, with AGP of ₹7000.
- (vii) Assistant Professors with completed service of 5 years at the AGP of ₹ 7000 shall be eligible, subject to other requirements laid down by the AICTE and the state government, to move up to the AGP of ₹8000.
- (viii) Posts of Associate Professors shall be in the Pay Band of ₹37400-67000, with AGP of ₹9000. Directly recruited Associate Professors shall be placed in the Pay Band of ₹ 37400-67000 with an AGP of ₹9000, at the appropriate stage in the Pay Band in terms of their conditions of appointment.
- (ix) Incumbent Assistant Professors and Lecturers (Selection Grade) who have completed 3 years in the pre-revised pay scale of ₹12000-18300 shall be placed in Pay Band of ₹37400-67000 with AGP Pay of ₹9000 and shall be re-designated as Associate Professors.
- (x) Incumbent Assistant Professors and Lecturers (Selection Grade) who have not completed three years in the pay scale of ₹12000-18300 shall be placed at the appropriate stage in the Pay Band of ₹15600-39100 with AGP of ₹8000 till they complete 3 years of service in the grade of Lecturer (Selection Grade), and thereafter shall be placed in the higher Pay Band of ₹37400-67000 and accordingly re-designated as Associate Professor.
- (xi) Lecturers (Selection Grade) in service at present shall continue to be designated as Lecturer (Selection Grade), as the case may be, until they are placed in the Pay Band of ₹37,400-67000 and re-designated as Associate Professors in the manner described in (x) above.
- (xii) Assistant Professors completing 3 years of teaching in the AGP of ₹8000 shall be eligible, subject to other conditions that may be prescribed by the AICTE and the State Government to move to the Pay Band of ₹37400-67000 with AGP of ₹9000 and to be designated as Associate Professors.
- (xiii) Associate Professors completing 3 years of service in the AGP of ₹ 9000 and possessing a Ph. D. degree in the relevant discipline shall be eligible to be appointed and designated as Professors, subject to other conditions of academic performance as laid down by the AJCTE and the
- State Government. No teacher other than those with a Ph. D. shall be promoted, appointed or designated as Professor. The Pay Band for the post of Professors shall be ₹37400-67000 with AGP of ₹10000.


