1. 



AND

**Govt. Pharmacy College, Rohroo, Distt. Shimla (HP)** having its campus at Rohroo, Distt. Shimla (HP) represented herein by its Director/Principal, Dr. Vivek.

(GPWK and GPCR are hereinafter jointly referred to as 'Parties' and individually as 'Party')

### WHEREAS:

A) GPWK is engaged in imparting quality education in following Diploma programmes streams

Computer Engg.  
Electronics & Communication Engg.  
Pharmacy

Govt. Pharmacy College, Rohroo is engaged in imparting quality education in Degree programme in pharmacy.

B) WHEREAS Govt. Pharmacy College, Rohroo has on mutual Agreement with GPWK consented to impart technical skills and train the students of GPWK who so ever they find eligible in their organization.

C) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

### CLAUSE 1

Govt. Pharmacy College, Rohroo has agreed to provide training and expert lecture to the pharmacy students by conducting it in Campus of GPWK.

**CLAUSE 2****CO-OPERATION**

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.

The general terms for co-operation shall be represented by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical enter into all relevant agreements, deeds and documents (the 'Definitive Documents') The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

**CLAUSE 3****OBJECTIVE OF THE MOU**

- Realizing the common goals of Technical Education, Training to empower students to participate effectively in the processes of national development in India.
- Provision of qualitative education through cutting-edge facilities and faculty in a conducive environment.
- Mutual acknowledgement of the experience, expertise and capabilities of GPWK and Govt. Pharmacy College, Rohroo and give due importance to collaboration and working relationship in education and skill development.
- GPWK and Govt. Pharmacy College, Rohroo have agreed to sign this Memorandum of Understanding which will lay the foundation for their relationship.

**CLAUSE 4****OBLIGATIONS EME TECHNOLOGIES**

- To give technical inputs through Seminars, Workshops, Trainings and other skill imparting activities to the students of GPWK.
- To allow the publication of the relationship of Govt. Pharmacy College, Rohroo and GPWK for promotional purposes through use of its Logo etc to GPWK.
- To help GPWK in organising or participating in student centred events such as Job fair, Annual Day etc.

**CLAUSE 5****OBLIGATIONS OF GPWK**

- To provide all necessary information, venue and infrastructure like class rooms, labs, seminar rooms etc to officials of Govt. Pharmacy College, Rohroo for conduct of training sessions by them for GPWK students in the campus of GPWK or as may be mutually agreed upon

- GPWK will be responsible for the incorporation and execution, through methodology, programme execution, presentation materials, class room teaching, lab work of the modules provided by Govt. Pharmacy College, Rohroo in its course curriculum if required or agreed upon both the parties.

#### **CLAUSE 6**

#### **DISPUTE RESOLUTION**

If any dispute should arise between the Parties, the parties shall try and resolve the dispute amicably. In the event of failure to resolve such dispute amicably, either Party may take the same to arbitration by giving 60 days written notice to the other Party. The Arbitration shall be conducted in accordance to the rules of the Indian Arbitration and Conciliation Act, 1996. The venue of such Arbitration shall be Punjab, India.

#### **CLAUSE 7**

#### **CONFIDENTIALITY**

All materials and information provided to a Party by the other Party or acquired by a Party on behalf of the other Party, whether oral, written, recorded magnetic media, cards, or otherwise, shall be regarded as confidential information in accordance with the applicable laws, ethical standards. Each Party shall take all necessary steps to safeguard the confidentiality of such materials or information. Neither Party shall use the confidential information of the other Party for purposes other than those contemplated hereunder.

#### **CLAUSE 8**

#### **INTELLECTUAL PROPERTY**

Nothing contained in this MOU shall, by express grant, implication, estoppels or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

#### **CLAUSE 9**

#### **VALIDITY OF THE MOU**

This MOU is valid for a period of one year with effect from the date of signing of this MOU and can be renewed by Mutual consent thereafter. Once agreed, the MOU shall be in force for a minimum period of 1 year.

#### **CLAUSE 10**

#### **RELATIONSHIP BETWEEN THE PARTIES**

It is expressly agreed that GPWK and Govt. Pharmacy College, Rohroo are acting under this MOU as independent Representative, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

**CLAUSE 11**

**BINDING NATURE OF THE MOU**

The MOU is intended to provide a legally non-binding procedural framework to enable the Parties to work together cooperatively towards achieving the goals set forth at the outset of the MOU. Any apparently mandatory language herein such as "shall" or "will" is intended to merely express the Parties' non-binding intentions hereunder and is not intended to create any legally enforceable obligations against either Party. Notwithstanding anything to the contrary, no obligation, covenant, or agreement relating to this MOU shall be binding on the Parties, other than the obligations specified in Clauses 1, 7 and 8 above.

**CLAUSE 12**

**GENERAL**


Each of the Parties hereto undertake with the other to act in the utmost good faith in interpreting and implementing this MOU and agrees to do all things reasonably within its power which are necessary or desirable to give effect to the spirit and intent of this MOU.


This MOU is the first documented agreement between the Parties; in case of contradictions between it and future agreements, the later one is binding.


Either Party may terminate this MOU upon providing thirty days written notice to the other Party,


This MOU may be executed in two or more counterparts, each of which shall be deemed an original and all of which together shall constitute one and the same document.
