HOSTEL FACILITY:

The institute provides a dedicated hostel facility for female students, located in a multi-storey building at the entrance of the campus. This hostel can accommodate approximately 90-100 students. Final year students are allocated single rooms, while other students reside in triple occupancy rooms. Additionally, a ground floor room is reserved for Divyang students in every session, ensuring accessibility for all.

The hostel is equipped with essential infrastructure including reliable water and power supply, safe drinking water facilities, and recently installed Wi-Fi connectivity. A public announcement system has also been extended to the hostel premises, enhancing communication and safety. Regular maintenance and cleaning of water facilities, along with CCTV surveillance, contribute to maintaining discipline and security within the hostel.

To address potential electricity issues during winter sessions, the hostel is equipped with a backup generator (GENSET), ensuring uninterrupted power supply to support students' academic activities. The aesthetically pleasing campus and hostel environment foster a homely atmosphere conducive to extended study hours and personal growth.

In addition to these amenities, the hostel provides vending machine facilities for students' convenience, along with a sanitary napkin disposal machine, promoting hygiene and comfort for female students. These facilities are designed to enhance the overall living experience and well-being of the students residing in the hostel.

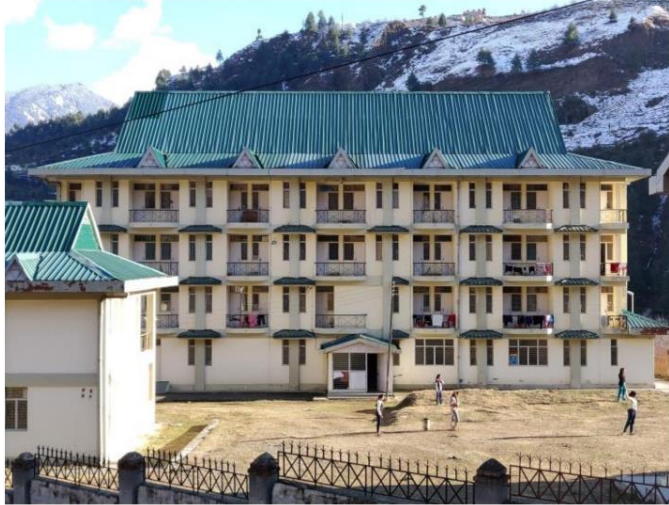
