3.1.1.1 Total Grants from Government and non-governmental agencies for research projects/endowments in the institution during the year (INR in Lakhs)

During the academic year 2023-24, Govt. College of Pharmacy, Rohru, achieved a significant milestone in research and development by securing a research grant of ₹5,00,000 sanctioned on 03-10-2023 from ECSO Global Private Limited (ABSOLUTE), a reputed non-governmental agency. The project, titled *"Building a Nature Intelligence Platform: A Repository of Novel Species of Microbes Found in Extreme Climatic Regions Through the Application of Novel Biotechnological Tools,"* is an ambitious initiative aimed at identifying, documenting, and analyzing unique microbial species from challenging climatic zones.

The research project, under the leadership of Principal Investigator **Dr. Vineet Mehta**, and Co-investigators **Dr. Priyanka Nagu**, and **Dr. Pankaj Sharma** from the Pharmacy Department, commenced in 2023 with an initial duration of three months, later extended to a 12 months timeframe due to its promising scope and potential impact. This project leverages cutting-edge biotechnological tools to establish a Nature Intelligence Platform, serving as a repository for novel microbial species.

Xenesis, an R&D division of Absolute, is on a mission to build a Nature Intelligence Platform, a repository of novel species of microbes found in nature. This ground-breaking initiative is geared towards enhancing our understanding of Indian biodiversity through the application of novel biotechnological tools and the reinforcement of our microbial library. The primary objective of this project is to strengthen our Nature Intelligence Platform (NIP) by collecting microbial samples from extreme climatic zones. Govt. College of Pharmacy, Rohru became the 1st Govt. institute in the Technical Education Department to receive external research grant. Xenesis recognized the research potential of the PI and Co-PI through multiple rounds of presentations and awarded this project to GCP.
