
1. Spoken Tutorial Program

Pankaj Jinta (Assistant Professor, Pharmacognosy) holds the charge of Spoken tutorial. Around 246 students of GCP Rohru underwent training under the program and successfully qualified. The program provided an opportunity for students to learn various open-source softwares through recorded lectures delivered by experts from IIT Bombay. Under this program, students are trained in the software every semester, and at the end of the semester, they take an online test conducted by IIT Bombay to earn certifications.




