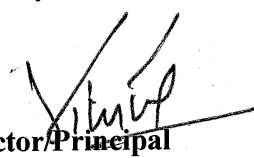
Instructions for the Candidates:

1. All eligible candidates intending to participate in the Direct Entry Spot Round shall report at the Institute on 26 August 2026 within the prescribed reporting time.
2. Candidates are required to bring all original certificates/documents along with one set of self-attested photocopies for verification.
3. Candidates should specifically bring the following documents, as applicable:
 - Matriculation/10th certificate as proof of date of birth.
 - Qualifying examination (10+2 Science) certificate and marks sheet.
 - Migration/Transfer Certificate
 - Character Certificate.
 - Bonafide/Category Certificate, wherever applicable.
 - Aadhaar Card or any other valid identity proof.
 - Himachali Bonafide/Category Certificate, wherever applicable.
 - Recent passport-size photographs.
 - Any other document prescribed by the competent authority/HPTU.
4. Mere participation in the Spot Round shall not confer any right to admission. Admission shall be granted only to eligible candidates against available vacant seats and strictly in accordance with the applicable admission rules and merit.
5. The candidates selected for admission shall be required to deposit the prescribed admission fee within the stipulated time. Failure to deposit the fee within the prescribed period may result in cancellation of the offered seat.
6. The candidates are advised to ensure that all the information furnished by them and the documents produced for verification are correct, genuine and complete. Admission

obtained on the basis of incorrect or misleading information shall be liable to cancellation.

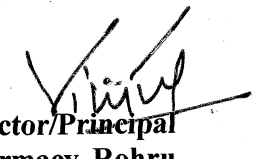
7. The number of seats available for the Spot Round shall depend upon the actual vacant seats available at the time of admission. The institute reserves the right to modify the number of seats subject to the directions of the competent authority/University.
8. Candidates are advised to remain present personally for document verification and completion of admission formalities.
